Providing education and training to enhance the capacity of local governments to deal with communications, information technology, cable and broadband issues.

Providing education and training to improve the administration of cable and broadband franchises and the use of communications, information technology and cable systems by local governments, including the development and creation of public, educational and government (PEG) channels.

Providing technical and other informational assistance to the membership.

Researching, representing, and advocating - as appropriate - for local government and community needs in the use, development, and regulation of communications, information technology, cable and broadband systems, in accordance with the policies developed and approved by the membership.

Providing a forum for open and balanced discussion and debate of controversial issues.

Communicating cooperatively with other professional organizations for the improvement of communications and information technology services to the public.

Assisting in the development and operation of broadband and information networks for local communities.

MEMBERSHIP CATEGORIES

INDIVIDUAL

Open to any individual who is currently elected, appointed, employed by, or primarily retained by a municipal, county, or state government, or a regional authority engaged in the regulation, administration, programming or planning of communications systems in the states of Georgia, North Carolina, South Carolina, or Tennessee.

- INDIVIDUAL members shall have voting rights in all SEATOA and committee business.
- INDIVIDUAL members shall participate in all committee business, including election of the Board of Directors and approving amendments to the Bylaws.

ASSOCIATE

Open to any individual from a non-profit or profit-making organization, or students involved in the planning, development, programming, or research of communications systems who do not qualify for Individual membership.

- Also open to individuals who meet the criteria for Individual membership, but who instead wish to exercise the option to join as an ASSOCIATE member.
- ASSOCIATE members are non-voting and shall receive the SEATOA Member Directory.
